I am writing to you as the current recorded public officer of the above association.

The Associations Incorporation Act 2009 requires an Annual summary of financial affairs be lodged with the Registry every year within one month of the date of the annual general meeting (AGM) and no later than 7 months after the end of the association's financial year.

The Registry's records show the association has failed to lodge its Annual summary of financial affairs as required. The association is now required to lodge its outstanding Annual summary of financial affairs (Form A12) for the financial year(s) **2008 and 2009**. Each Form A12 must be accompanied by the prescribed fee, being the filing fee together with the late lodgement fee for each annual statement as appropriate. The fees are listed on Form A12.

If the public officer or the official address of the association has changed Form A9 - Notice of appointment of public officer & Notice of change of association address must also be completed and lodged.

The forms are available from the Fair Trading website at [www.fairtrading.nsw.gov.au](http://www.fairtrading.nsw.gov.au) your nearest Fair Trading Centre or the Registry of Co-operatives & Associations on the above telephone number. The forms should be completed and returned to the Registry by no later than **11th April 2011**.

Penalties may apply for failure to lodge Annual summary of financial affairs.

Please do not hesitate to contact the Registry should you require any assistance or advice in relation to the action required by this association.

In addition, you should be aware that action may be taken to cancel the incorporation of an incorporated association where the association has failed to lodge an Annual summary of financial affairs during the last 3 financial years.

Please ensure this letter is brought to the attention of the committee as soon as practicable after receipt.
